1. Purpose

This regulation *a.* Prescribes policy for the voluntary reduction in rank of officers and enlisted personnel throughout the Virginia Defense Force.

2. References

a. Code of Virginia Title 44: Military Laws of Virginia.

b. Permanent Order 1-1 (VaDF) TAG, VA 1 March 1988.

3. Responsibilities

- a. The Deputy Chief of Staff G-1 will-
- (1) Prescribe policy, procedures and implementing instructions on the use and construction of abbreviations.
- (2) Supervise and manage the abbreviation program for the Virginia Defense Force.
- (3) Review and approve/disapprove requests for new or modified abbreviations.

Chapter 1 Reductions

1-1 Officer Reduction:

- a. Voluntary reduction may be requested by an officer to accept assignment to a Cadre position vacancy of a lesser grade.
- b. Request for voluntary reduction will be prepared in letterform and forwarded to the appropriate authority listed in Table 1-1.
- c. Reduction orders will be published by the authority designated and will state "Voluntary Reduction without Prejudice."
- d. The time in grade accrued prior to voluntary reduction will be maintained and may be applied to subsequent service if the individual is administratively returned to his or her previous rank.

1-2 Enlisted Reduction:

- a. Voluntary reduction may be requested by an enlisted member to accept assignment to a Cadre position vacancy of a lesser grade.
- b. Request for voluntary reduction will be prepared in letterform and forwarded to the appropriate authority listed in Table 1-1.
- c. Reduction orders will be published by the authority designated and will state "Voluntary Reduction without Prejudice." Time in grade accrued prior to voluntary reduction will be maintained and may be applied to subsequent service if the individual is administratively returned to his or her previous rank.
